Proposed Action

That the Metropolitan Council commit \$2M in council-controlled funds to leverage a \$6M Counties Transit Improvement Board (CTIB) funding commitment to complete METRO Orange Line Project Development and Engineering activities.

Background

The METRO Orange Line is a 17-mile bus rapid transit corridor along I-35W from downtown Minneapolis to Burnsville. This \$150 million transitway line consists of transitway stations, a park-and-ride facility, BRT buses, and related facility and technology improvements and professional services.

In August 2014, Metro Transit requested Federal Transit Administration to allow Orange Line to begin Project Development activities. Project Development includes preliminary and final engineering, environmental analysis, and other activities to prepare the Orange Line for construction in 2017.

Rationale

To consider the Council's application for Orange Line Project Development, the FTA requires a funding commitment from CTIB for its share of Project Development funding. To provide its commitment, CTIB has requested a formal commitment of the Metropolitan Council's planned funding share of \$2 million. These funds will be reflected in the 2015-2020 Capital Improvement Plan scheduled for Council approval in December 2015. The funds will be authorized through future Council budget amendments.



Funding

Orange Line Project Development and Engineering is budgeted at \$10 million. Project Development funding is comprised of three sources:

- \$6 million in CTIB funds disbursed through annual grant requests for 2015 and 2016, secured by the requested commitment. The project must be in Project Development to use CTIB funds.
- \$2 million in state funds, drawing from \$2 million state bonds and \$1 million supplemental appropriation funds secured in 2014 for I-35W and Lake Street Transit Station. Remaining state funds will carry forward to future project phases at I-35W and Lake Street.
- \$2 million Council-controlled funds committed through the requested action and attached resolution.

The exact funding source distribution for the Council's \$2 million commitment will be identified prior to future budget amendment(s) that authorize the funds. Anticipated sources include Regional Transit Capital, federal formula, or other current or future funding streams under Metropolitan Council control.

Known Support / Opposition

Hennepin and Dakota County Regional Rail Authorities are scheduled to adopt resolutions of support for a CTIB Project Development Funding Commitment this month. CTIB is expected to approve the Funding Commitment on October 15, contingent to the approval of the Council's funding commitment.
