## **Call to order**

A quorum being present, Council Chair Zelle called the regular meeting of the Metropolitan Council to order at 4:00 p.m.

### Agenda approved

Council Members did not have any comments or changes to the agenda.

### **Approval of minutes**

It was moved by Lilligren, seconded by Wulff to approve the minutes of the February 14, 2024, regular meeting of the Metropolitan Council. **Motion carried**.

### **Public invitation**

AFSCME union members spoke to the Council about ongoing bargaining efforts.

### **Consent business**

Consent business adopted

- 1. 2024-31: That the Metropolitan Council authorize the Regional Administrator to execute Amendment 1 to Subordinate Funding Agreement #19I034G with the City of Woodbury for construction of non-project activities concurrent with the Gold Line Bus Rapid Transit Project for a total contract amount not to exceed \$2,136,383.69
- 2. 2024-33: That the Metropolitan Council approve the Administrative Process for Minor Long-Range Plan Amendments with one amendment to modify the boundary change dollar limit to \$750,000 total as described in the Updated Attachment 1 of this report (below).
- 2024-40: That the Metropolitan Council (Council) authorize the Regional Administrator to negotiate and execute Amendment No. 5 to Contract 19M152 with Twin Cities & Western Railroad (TCWR) for freight rail flagging services to add \$4.25 million for a total amount not to exceed \$13.75 million.
- 4. 2024-42: That the Metropolitan Council approve the attached parameters Resolution 2024-2, which authorizes the Regional Administrator, or Deputy Regional Administrator, to execute a

project loan agreement with the Minnesota Public Facilities Authority (PFA), in substantially the form as the attached draft agreement, and authorizes the issuance and sale of the supporting General Obligation Wastewater Revenue Note securing the loan, in substantially the form as the draft Note referenced in the Resolution.

- 5. 2024-44: That the Metropolitan Council authorize the Regional Administrator to negotiate and execute agreement 23I029 with Hennepin County for the County's construction of METRO E Line BRT station platforms in conjunction with the County's University and 4th Roadway Improvement Project in the amount of \$2,550,000.
- 6. 2024-46: That the Metropolitan Council authorize the Regional Administrator to execute a sole source contract 22P150 with Trapeze Software Group, Inc., to provide scheduling software in an amount not to exceed \$1,702,555.
- 7. 2024-48 SW: That the Metropolitan Council amend the 2024-2027 Transportation Improvement Program (TIP) as follows:
  - Increase the cost and change the intersection treatment from a signalized intersection to a roundabout at for Carver County and MnDOT's CSAH 10 and CSAH 41 intersection projects;
  - Decrease the cost of MnDOT's I-694 drainage project; and Increase the cost of MnDOT's pier repair project on US952A.

 2024-47: That the Metropolitan Council authorize the Regional Administrator to execute sole source contract 24P004 with Cubic Transportation Systems to upgrade technology and devices including ticket vending machines (TVMs), rail smart card validators (RSVs), Point of Sale systems, as well as handheld inspection devices, new technology smart cards, and spare parts for a regional fare collection system in amount not to exceed \$37.7 million.

2. 2024-50 SW: That the Metropolitan Council adopt Revision 6 of the Bus Transportation Agency Safety Plan and the Light Rail Transportation Agency Safety Plan for Metro Transit as required by 49 CFR Part 673

3. 2024-59 SW: That the Metropolitan Council adopt Revision 3 of the Agency Safety Plan for Metropolitan Transportation Services (MTS) as required by 49 CFR Part 673.
