Enhanced Mobility for Seniors and Persons with Disabilities

REQUESTED MnDOT requests an amendment to include in the 2017-2020 TIP

ACTION: funding for three "Enhanced Mobility for Seniors and Persons with

Disabilities" projects.

RECOMMENDED Recommend that TAB adopt the amendment into the 2017-2020

MOTION: TIP to include funding for "Enhanced Mobility for Seniors and

Persons with Disabilities" projects.

BACKGROUND AND PURPOSE OF ACTION: MnDOT was awarded funding from Federal Transit Administration (FTA) Section 5310's Enhanced Mobility for Seniors and Persons with Disabilities program, which is funded by FTA through MnDOT's Office of Transit. The selection of these projects is done through grant applications submitted to FTA. The timing of project selection is not compatible with the TIP development and to identify them in the current TIP, an amendment is necessary.

RELATIONSHIP TO REGIONAL POLICY: Federal law requires that all transportation projects that will be funded with federal funds must be in an approved TIP and meet the following four tests: fiscal constraint; consistency with the adopted regional transportation plan; air quality conformity; and opportunity for public input. It is the TAB's responsibility to adopt and amend the TIP per these four requirements.

STAFF ANALYSIS: The TIP amendment meets fiscal constraint because the local and federal funds are sufficient to fully fund the project. The amendment is consistent with the Transportation Policy Plan, adopted by the Metropolitan Council on January 14, 2015 and with FHWA/FTA conformity determination established on March 13, 2015. The Minnesota Interagency Air Quality and Transportation Planning Committee determined that the projects are exempt from air quality conformity analysis. Public input opportunity for this amendment is provided through the TAB's and Council's regular meetings. This amendment meets the criteria for using the TAB's streamlined TIP amendment process and was recommended for streamlining by the TAC Executive Committee.

These amendments will specifically identify Section 5310 Large Urban Mobility Management projects for program year 2018. The 2017-2020 STIP needs to be amended due to the fact that the grant application for these projects will be written prior to the 2018-2021 STIP Approval.

Section 5310: the Enhanced Mobility for Seniors and Persons with Disabilities program is funded by FTA through MnDOT's Office of Transit. The final selection and award of these on-going Mobility Management projects is done through grant applications submitted to MnDOT. The timing of final project selection is not compatible with the FTA grant application deadlines which will need to be met in order to execute grant contracts for calendar year 2018.
