The Minnesota Unified Certification Program (Mn/UCP) was established to offer a "one-stop" shop for certification of Disadvantaged Business Enterprises (DBEs) in Minnesota for U.S. Department of Transportation-funded contracts. The Mn/UCP is made up of all government agencies in Minnesota that receive federal funds from the US/DOT for transportation projects in the state. The Minnesota Department of Transportation, Metropolitan Airports Commission and the Metropolitan Council make up the Certification Application Committee (CAC) and are responsible for voting on DBE certification applications. DBE Specialists at these agencies evaluate the DBE applications received by each agency and make recommendations on certification approvals to the entire CAC, which meets every two weeks.
