Notice is given that on **May 9, 2024 at 2:00PM** the Metropolitan Council will receive and publicly open separate sealed bids for North Loop Garage Gutters and Heat Trace, Project Number 62312, Contract Number 23P193.

The work of this project includes installing snow guards and a gutter system on the sloped steel roof on the south side of the building. The existing heat trace system will be expanded to extend into the new gutter system as shown in the attached plans. The base work shall include all work necessary for the additional heat trace cables and all associated work to add onto the existing heat trace system, including the necessary roof or wall penetrations matching similar materials used for adjacent roof penetrations.
