**2. 2021-27** 2022 Regional Solicitation: Unique Projects

TAC Chair Jon Solberg presented this item.

Look asked about what unique projects have been proposed. Hovland said no projects have been proposed yet this is just establishing the category. Barber voiced concerns for weighting. Hollinshead reiterated that the ranking as is incorporates equity. Hiniker added that more unique project information can be brought back in December.

**3. 2021-28** 2022 Regional Solicitation: Modal Funding Ranges

TAC Chair Jon Solberg presented this item.

Jalali asked for plain language definitions. Jalali said she would not necessarily support the current modal funding ranges. Foster stated that mode ranges should be shifted to reflect the priorities of the TAB. Narayanan commented on the funding that currently goes to maintain and said he supports

moving funding away from highway. Geisler said the number one goal of TAB is the health of the transportation system border to border. Look brought up studies on emissions. Windschitl noted that many discussion hours have been spent on this topic and the conclusion has been to let these ranges run through a cycle. Lindeke said there has been research on induced demand to show that expanding roadways does increase driving. Jeppson commented that a lot of projects already require bike/ped accommodations and she voiced concern for safety. Goettel reminded the group that walkways are included when roads are redone. Hollinshead said there is an asymmetry of funding with transit and private motor vehicles. Jalali said this amendment is a modest shift to move out of the cycle many communities are in. MatasCastillo agreed this is a slight change. Johnson commented that desires don't line up with the current reality that people have seen since COVID. Ulrich said bike and ped are in tandem when roads are built, very few trails were built separate from a road. Sanger voiced support for the amended motion and added that some projects really ought to have an equity component. Steffenson commented on current need for expansion. Anderson echoed the current reality. Kealey commented that more money may be needed. Schember reminded the members that bike and ped do not move freight through the region and if freight is congested eventually the consumer bears the cost. Dugan agreed that one cycle is necessary to see first. Biewen noted in the chat, "I am going to enter my opinion here, because of the large backlog of hands raised and for efficiency's sake. I will start by saying that I have every interest in reducing the environmental impact from our transportation system. I have been on TAB through one cycle of dispersing funds in the solicitation process. I was very impressed with how the TAB functioned through this process. There was give-and-take, there was compromise, there were county commissioners willing to give up something that would directly benefit their county. There was collaboration and recognition that we are working within a larger system - 7 counties. I like the direction of putting more money toward transit and biking/ped. For this vote, I just think the ranges allow us to do this and I want to maintain my confidence that together we can debate the projects that come before us and choose within the ranges we currently have." Bailey noted in the chat, "I also agree with the original motion. As a growing southeast metro city (Cottage Grove) - we are feeling the growing pains and need help reduce the congestion on Highway 61 and 494. Now is not the time to change the funding for roads and bridges. Safety is more than pedestrian concerns alone. We need to understand the importance of safe roads and bridges are as much a concern as pedestrian concerns. Mass transit is extremely limited to most our ring suburbs. I would like to see more funding for all categories described. But the most important part of this formula is the funding for roads and bridges." Reich asked for data in the future ahead of these conversations so members are not relying on anecdotes. Reich and Kauppi commented on flexibility and Reich added that TAB accept the proposed modal funding ranges as reflective of historical averages from past solicitations but that TAB reserves the opportunity to allocate funding outside of these ranges based on a full understanding of the cohort of projects and how they relate to the Region's stated and agreed upon policies around system stewardship, safety, multimodal access, equity/sustainability/health, and guiding land use.

Foster moved Narayanan seconded a change to the funding range as shown below:

- 2. Recommend that the MnDOT Commissioner submit all of the changes from the functional classification study to the Federal Highway Administration for approval.
