    - Better understanding of the Met Council's work
    - Regional Fare Change Policy and TAP recommendations
  - o What are some of the challenges we have faced?
    - Inconsistent attendance
    - Not enough time to discuss topics/policies fully
    - Desire to be more focused on system-wide change
    - Confusion around how the Council works
    - Lack of clarity in how EAC agendas/work plans are formed
    - Council has limited influence in the Region
  - o Where do we want to go?
    - EAC would like to be closer to inception and the impact assessment
    - Consider changing frequency of meetings to allow for more indepth engagement pf policy topics
    - Better understand EAC's role
    - Community organizing/engagement of constituents
