## **Comment Overview**

This report serves to summarize public comments received for the draft 2024 budget and levies for the Metropolitan Council. The budget was released for public comment on Oct. 25, 2023. Between that time and Dec. 13, 2023, the Metropolitan Council received four comments from residents of the region. These comments are included, in full, in this report. During the public comment period, the draft budget and plain language summaries were available on the Metropolitan Council's website and through printed copies as requested.

The Met Council proactively promoted availability of the comment draft, including advertising it and the public hearing through social media, through Council members to each of the 16 districts, and other means. An opportunity for in-person comment from members of the public was provided at the regularly scheduled meeting of the Metropolitan Council on Dec. 13, 2023. During the meeting, two people provided comments related to concerns regarding their overall property tax bills, including all local governments, school districts, etc. They did not specifically question the Metropolitan Council portion of their tax bills.
